A **Specimen Tree** is any tree, in fair or better condition, which qualified for special consideration for reservation due to size, species, or condition, and which meets the following DBH (diameter at breast height):

- 27" DBH - Large Hardwoods (Oak, Hickory, Poplar, Sweet Gum, Magnolia, large Holly, etc.)
- 30" DBH - Large softwoods (Pine, Cedar, etc.)
- 8" DBH - Small trees (Dogwood, Redbud, Cherry, etc.)

**C. SPECIMEN TREE REMOVAL**

- Calculate the Specimen Tree Removal fee at \$250 for each Tree Density Unit of the Specimen Tree(s) removed.  
**For example, one 24" DBH Oak = 4.4 units x \$250.00/unit = a fee of \$1,100.**
- The Tree Removal Permit shall not be issued, nor shall the specimen(s) be removed, until all fees are received or specimen tree replacement has been indicated on an approved Tree Replacement/Landscape Plan. **Any** Specimen tree removal without or prior to the issuance of a Tree Removal Permit may result in a penalty assessed at three times the normally calculated fee.

**GENERAL PROVISIONS**

1. Refer to the City's Tree Protection & Landscape Ordinance for more information regarding tree protection, removal, or replacement.
2. A Tree Removal Permit is required:
  - a. To remove any tree larger than eight inches (8") in diameter from any property.
  - b. To remove more than three trees that are smaller than eight inches (8") in diameter from any property.
3. Refer to the Garden City Regulatory Fee Schedule for all fees associated with a Tree Removal Permit.
4. Some Tree Removal Permits may be issued without a fee.
5. If any tree larger than eight inches (8") in diameter is removed without a Tree Removal Permit, the property owner shall pay a fine of three times the City's tree removal permit fee.
6. A Tree Removal Permit is required in addition to the Land Disturbance Activity Permit.
